Job Descriptions:

Public Service Commission: regulates telecommunications, electric, and natural gas services

Sheriff: responsible for law enforcement

Clerk of the Superior Court: official record keepers of the county

Tax Commissioner: responsible for the collection and processing of taxes

Solicitor General: Responsible for prosecution of misdemeanors

District Attorney: Represents the state government in criminal cases
